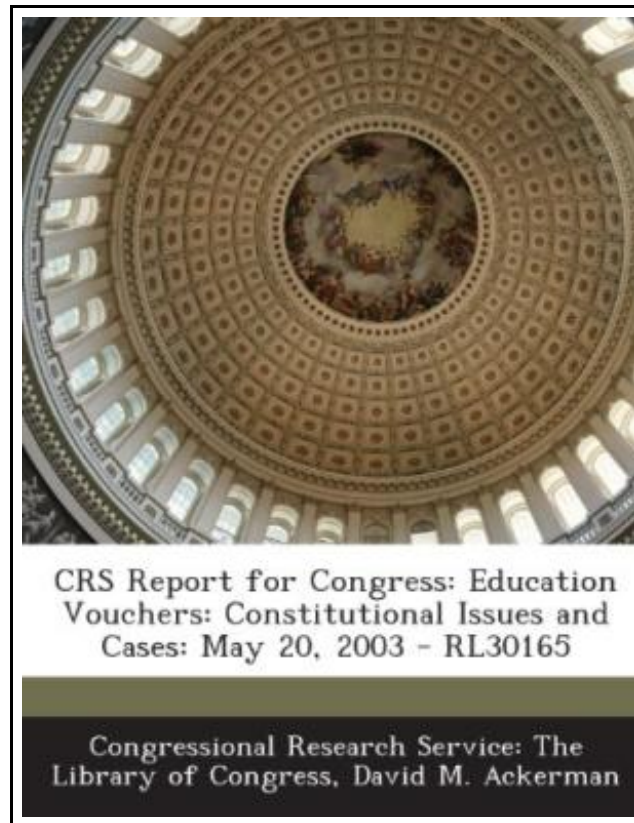

On May 19, 2003, the Supreme Court agreed to review a lower federal court decision *Davey v. Locke* which held the free exercise clause of the First Amendment to be violated by a provision in a state constitution barring a state scholarship from being used for a theological major at a religious college. Such no religious use provisions exist in a number of state constitutions and have become the focus of a number of suits in the wake of the Supreme Courts 2002 decision in *Zelman v. Simmons-Harris*. In *Zelman* the Court, by a 5-4 margin, upheld the constitutionality under the establishment of religion clause of the First Amendment of a school voucher program that gave tuition assistance to poor children in failing public schools in Cleveland to enable them to attend private schools in the city, notwithstanding that most of the schools were religious in nature. In so doing the Court substantially loosened the constraints that previously applied to voucher programs under the establishment clause and shifted the attention of voucher advocates and opponents to state constitutional provisions that have been, or might be, construed to prohibit such programs.
